GREATER VANCOUVER TRANSPORTATION AUTHORITY BY-LAW NUMBER 23-2002

A By-law to amend the Greater Vancouver Transportation Authority 2001 Tariff Amendment By-law Number 22-2001

WHEREAS there has been wide consultation and approval of a fare increase;

AND WHEREAS the Greater Vancouver Transportation Authority has an interest in encouraging greater purchase and use of pre-paid fares, by providing for group travel on Sundays and holidays, at no extra charge;

NOW THEREFORE the Board of Directors of the Greater Vancouver Transportation Authority enacts as follows:

- 1. This By-law may be cited as the "Greater Vancouver Transportation Authority 2001 Tariff Amendment By-law Number 23-2002."
- 2. The Greater Vancouver Transportation Authority Transit Tariff, attached to the Greater Vancouver Transportation Authority 2001 Tariff Amendment By-law Number 22-2001, will be amended as follows:
- (a) Under "Annual Employer Transit Pass Program" in Section B Terms & Conditions of Part 1 Conventional Transit, delete the following from the paragraph entitled "Applicable":
 - On Sundays, and Public Holidays, Annual Employer Transit Passes are valid for two adults and up to four children.
- (b) Under "Monthly FareCards" in Section B Terms & Conditions of Part 1 Conventional Transit, delete the following:
 - (i) On Sundays, and Public Holidays, Adult FareCards on are valid for two adults and up to four children.
- (c) Under "Annual Employer Transit Pass Program" in Section B Terms & Conditions of Part 1 Conventional Transit, insert the following at the end of the paragraph entitled "Applicable", effective May 5, 2002:
 - On Sundays, and Public Holidays, Annual Employer Transit Passes are valid for two adults, seniors or students and up to four children.
- (d) Under "Monthly FareCards" in Section B Terms & Conditions of Part 1 Conventional Transit, insert the following, effective May 5, 2002:

- (i) On Sundays, and Public Holidays, Monthly FareCards are valid for two adults, seniors or students and up to four children.
- (e) Under "Annual Employer Pass Program" in Section I Terms & Conditions of Part 3 West Coast Express, insert the following at the end of the paragraph entitled "Applicable," effective May 5, 2002:

On Sundays, and Public Holidays, Annual Employer Passes are valid for two adults, seniors or students and up to four children.

(f) Under "28-Day Pass" in Section I – Terms & Conditions of Part 3 –West Coast Express, insert the following at the end, effective May 5, 2002:

On Sundays and Public Holidays, 28-Day Passes are valid for two adults, seniors or students and up to four children.

3. This Bylaw come into force and takes effect on March 25, 2002.

READ A FIRST, SECOND AND THIRD TIME this 25th day of March, 2002.
